### **Company Criteria:**

### **Company Achievement:**

The company is committed to improving the environmental sustainability of Newfoundland and Labrador's energy industry. The company's innovation has contributed to the industry's endeavors to lower emissions, reduce its environmental footprint, and achieve net zero by 2050.

**Demonstrate how the company's implementation has achieved one or more of the following:**

### **Category 1 – Environmental Footprint:**

Through innovation, the member company has reduced Newfoundland and Labrador's energy industry's environmental footprint.

### **Category 2 – Net Zero 2050:**

Will contribute to achieving Newfoundland and Labrador's energy industry's goal of achieving net zero emissions by 2050.
